- Establish care with another psychiatrist in the area. A list of local providers is enclosed. You may also contact your insurance carrier for a list of in-network providers.

- March telehealth appointments will continue as scheduled through Fayetteville Psychiatry, Ltd., through March 30, 2026.
- Before March 30, 2026, please arrange to transfer your care to your primary care physician or another psychiatrist. A list of local providers is enclosed, and your insurance carrier can also assist with in-network options.

Therapy Patients of Amber Hooper

- March therapy appointments will continue as scheduled.
- Amber Hooper will continue seeing patients after March through She Blooms Mental Health. If you wish to continue therapy with Amber, please contact She Blooms Mental Health to complete intake paperwork and scheduling. A Release of Information form is enclosed to authorize transfer of your records.
